No vehicles will be permitted after 10:30 a.m. on the site. Spaces and spots will be assigned by the Food Vendor Chairperson. Set-up of tents and trailers is noted above. If this time is inconvenient, please contact me for alternate arrangements.

Remember: Vendors must be ready for health inspections 10:00 a.m. Fiesta day – no exceptions.

POWER REQUIREMENTS 2019 VIVA QUAD CITIES FIESTA

Provide the necessary temporary electrical requirements needed

EQUIPMENT ID	QUANTITY	VOLTAGE	AMPS (EA)

The Committee will not provide any extension cords. This is the Vendor's responsibility and should be a minimum of 12 gauge/3-wire and 25 foot length, for your 120 volt requirements. If 220 volt is required, please indicate if ends are bare wired or provide plug identification by looking at plug face, if more power than 50 amps, additional charges may apply. If you need water hookup you must bring your own hoses and backflow adapter.

Vendor space will be 10x20, there will be an extra charge for additional footage.

Vendors will need proof of insurance and an insurance certificate naming VIVA Quad Cities, the City of Moline as additional insured, with coverage at an amount minimum of One Million Dollars.

Vendors need to get a temporary health license from City of Davenport Health Department.
